

**Ashland City School District Board of Education – Work Session/Special Meeting Monday, September 2, 2015**


The Ashland City School District Board of Education met for a special meeting on Wednesday, September 2, 2015, at the Central Office, 416 Arthur St., Dr. James Wolfe, President, called the meeting to order at 7:30 a.m.

- I. ROLL CALL** Mr. Rick Ewing, Mr. Bryan Lefelhoc, Mr. William Gravitt, Mrs. Lindsay Saffle, and Dr. James Wolfe were present.
- II. PLEDGE OF ALLEGIANCE** The Pledge of Allegiance was led by Mr. Gravitt, Board Vice President.
- III. APPROVAL OF DEMOLITION CONTRACTS 2015-09-140** Dr. Wolfe motioned; second by Mrs. Saffle to approve the demolition of Lincoln Elementary by Great Lakes Demolition Company; Osborn Elementary by Pro Quality Land Development, Inc.; and Ashland Middle School by Baumann Enterprises, Inc. Motion carried 5-0.
- IV. EMPLOYMENT 2015-09-141** Mr. Ewing motioned; second by Mrs. Saffle to approve the following:
  - A. The employment of Elizabeth Metzger as a Social Studies teacher at Ashland High School for the 2015-2016 school year on a one-year limited contract at a salary of \$31,946.00 (Year 0, Step 0).
  - B. A one-year leave-of-absence for Ashley Clark Weaver, First Grade teacher at Edison Elementary School, for the 2015-2016 school year.
  - C. The employment of Shelly Beth Getz as a First Grade teacher at Edison Elementary School for the 2015-2016 school year on a one-year non-renewed contract at a salary of \$31,946.00 (Year 0, Step 0). This is a one-year leave-of-absence position.
  - D. The resignation of Ashley Gardner, Small Group Instructor, effective July 28, 2015.Motion carried 5-0


Certificate Section 5705.412, Revised Code




