Instructions for Completing a Work Permit Application

Front Page

Student/Applicant Information

• To be completed and signed by parent or guardian.

Pledge of Employer

• To be completed by the employer. Be sure that the 9-digit tax ID number and sections 1-4 with a specific number or time are completed.

Back Page

Physician's Certificate

• To be completed by a licensed physician. If you had an athletic physical at the high school, you may go to the athletic office to get a copy of your physical and return it to the main office. Physicals are good for one year.

<u>After all sections have been completed</u>, bring the application back to the Ashland High School main office. We will process it electronically within two working days to the State Department of Industrial Relations in Columbus. The student will need to return to the main office to sign the *Age and Schooling Certificate*, at which time a copy will be given to the student to give to their employer.

If you already have a work permit and are changing jobs, the *Student/Applicant Information & Pledge of Employer* sections are the only section that need to be completed at this time, as long as your physical is still current (under a year old). After you and your new employer have completed these sections, return it to the main office for processing.
